1. Promoter

This promotion is run by Winstone Wallboards Ltd (the **Promoter**).

2. Eligibility

- Entry into this promotion is open to the Promoter’s non-merchant customers, including builders, installers and contactors. Entrants must be aged 18 or over.
 - Entry is deemed acceptance of these terms and conditions.

 - The promotion starts on 11 March and ends at 5.00pm pm 29 May 2026 (the **Promotion Period**).

3. How to Enter

 - Only one entry per building site is permitted.
 - Images submitted during the Promotion Period will become the property of the Promoter on submission.
